Our company provides evaluation and rationalization of economic processes within your live system or systems;

- preparation for the implementation of the ERP system;
- > preparation of related studies, quotations, project design, ideas and proposals;

- full project management during system implementation, based on tested and confirmed methodologies;
- > within the collaboration with foreign implementation partners, the integration of local requirements for subsidiaries, taking into account the standard operation and international financial processes, Hungarian training with the pertaining user manuals;
- parameter setting for the consolidation of company groups, preparation of related reporting;
- creation of proper user interfaces, company-specific functions according to the requirements defined during implementation;
- creation of custom software used besides the ERP system, bank terminal interfaces;
- creation of custom reports, queries necessary for full management controlling;
